A regular meeting of the Quincy College Board of Governors was held on November 10, 1997 at 6:00 p.m. in the Sullivan Center.

## President's Report:

- Dr. Ryan reported that the Fall Enrollment is down about three percentalso, that the college has to do better retaining students.
- Dr. Ryan told the Board that Exit Interviews will be conducted with students to ascertain why they did not return to the college.
- Dr. Ryan announced the signing of an agreement with the Mass College of Pharmacy which will allow the Associate Degree Nursing Students to spend one year at the Mass College of Pharmacy and receive their degree.
- The Sullivan Center will have a new coordinator-Paul White has agreed to run the center.
- Mr. O'Neill thanked Joan McAuliffe who was very instrumental as the first coordinator of the Sullivan Center.
- Dr. Ryan asked Vice President Gilmore to present and briefly outline the College Organization.
- Ms. Gilmore presented the packet to the Board and reviewed it for the Board of Governors.

## Committee Reports:

Finance and Facilites Committee-presented by Mr. Farmer

Ms. Lincoln asked that her name not be placed in the Personnel and Programs Committee but rather that she be on the Community Development Committee.


Community Development Committee:
