How to Apply for Aid

You must complete a Free Application for Federal Student Aid (FAFSA) each year. The 2022-2023 FAFSA requires that you report 2020 income.

You must have an FSA ID to sign the FAFSA. If you are a dependent student, then your parent must also have an FSA ID. Go to fsaid.ed.gov to apply for one.

Use the IRS Data Retrieval Tool

You will be given the option in the Financial Information section of the FAFSA to link your tax return information directly from the IRS. We encourage you to utilize this tool, as it makes your FAFSA result more accurate.

If you are having difficulty linking your tax information when using the retrieval tool, be sure to check the following:

The tax filer s name on the screen matches the tax filer s name on the federal tax return

The tax filer s last 4 digits of SSN on the screen matches the tax filer s last 4 digits of SSN on the federal tax return

The tax filer s date of birth on the screen matches the tax filer s date of birth on the federal tax return

You have typed the address EXACTLY as it appears on the federal tax return. (i.e. if the street address is typed in all capital letters on the tax return, then you must type it in all capital letters when using the IRS Data Retrieval tool)

Dependent Students

Students under the age of 24 must use their parents income when completing the FAFSA. If you have a special circumstance, please contact the Financial Aid office.

The FAFSA will arrive at Quincy College in 5 to 7 business days. You will receive an email from Quincy College with follow up instructions.

Once all necessary documentation is received you will receive an award letter by mail. The award letter will arrive with the College s Satisfactory Academic Progress Policy (SAP).

SAP = Students are required to maintain a GPA of 2.0 and a successful completion rate of 68%. A mark of W does not affect your GPA, but it does affect SAP. Marks of Incomplete or F will lower your GPA. Students who do not meet the SAP requirements will be placed on warning and may lose their financial aid.

Your financial aid award is determined by the number of credits for which you have registered.

Full time = 12 credits per semester

¾ time = 9 -11 credits per semester

½ time = 6-8 credits per semester

Less than ½ time = less than 6 credits per semester

Less than ½ time students are not eligible to borrow loans.

PLEASE REMEMBER

Check your Quincy College portal and email regularly. This is our primary mode of contact. Look for emails from Quincy College that may have gone into your Junk/Spam folder.

Complete all requests for documents or information quickly. If you need some guidance on what we have requested, do not hesitate to reach out to us.

Be sure that your current address in our system is correct. You will receive an award letter in the mail when your financial aid is complete.

If you are offered a Direct Stafford Loan and you want to borrow it, you must be enrolled in 6 or more credits and complete the Entrance Counseling and Master Promissory Note for undergraduate students at **www.studentaid.gov**. If you do not wish to borrow loans, then you do not have to do anything.

Your award letter will include health insurance information. Waive your health insurance charges each year if you do not need coverage. The Business Office can address health insurance questions at **studentaccounts@quincycollege.edu**.

All students must provide their high school diploma, high school transcript, or proof of GED to the Admissions office. This is a requirement even if you have already attended another college. Official high school transcripts must be in a sealed envelope.

It is your responsibility to know how much financial aid you are getting and how much the college costs. If you still have a balance, you must make arrangements to pay it. Costs are listed on the Quincy College website at www.quincycollege.edu
